### **INDEPENDENT AUDITOR'S REPORT**

#### **Report on the Financial Statements:**

I have audited accompanying financial statements of PRECILLA CHARITABLE TRUST, D No.3-10-2, P.No.205, EDIFICE Apartments (Priya Beauty Parlar) RAMANTFIAPUR, HYDERABAD- TELANGANA STATE- 500013, which comprise *Balance Sheet as at 31<sup>st</sup> March 2021* and annexed Income & Expenditure Account and Receipts & Payments Account for the year ended.

#### Management's Responsibility for the Financial Statements:
