**AIMS AND OBJECTIVES OF THE TRUST**

**OBJECT OF THE TRUST:-**

- A. EDUCATIONAL OBJECTS:- Construction, maintenance and running of schools/colleges, universities, hostels for poor students, grant of stipend/scholarship/assistance in cash and kind to poor/deserving children, purchase and supply of educational and library material, books, educational laboratories social awareness programs, note books etc, conducting adult literacy programmers , conducting research, education/schools for the mentally challenged, non-formal education projects/coaching and any other activities related to the above youth counseling's.
- B. ECONOMICAL OBJECTS:-  
Following activities (Not being commercial or profit making activities)  
Self-help groups, self-sustaining income generation projects/schemes, agricultural activities, rural development, animal husbandry projects, setting up and running handicraft centre/cottage and khadi industry/social forestry projects, vocational training, tailoring, motor repairs, computer, micro-finance projects, including setting up banking co-operative and sorts of effective personal development courses etc., and any other activities related to the above not being commercial activities.
- C. Construction, maintenance and running of ashrams, dharma shalas, hospitals/dispensaries/clinics, community halls, old age homes, orphanages, shelters, welfare of the widows, old ages persons, holding of free medical/health/family welfare/immunization camps, supply of free medicines and medical aids, including hearing aids, visual aids, family planning aids etc, provision of supporting aids such as tri-cycles, calipers etc to the handicapped, treatment/rehabilitation of drug addicts.
- D. Welfare/empowerment of women, welfare of children, provision of free clothing/food/ to the poor, needy and destitute, relief/rehabilitation of victims of natural calamities, disasters, help to the victims of riots/other disturbances, digging of bore wells, sanitation including community toilets etc., awareness camps/seminars/Workshops/meetings/conference, providing free legal aid/running legal aid centers, holding sports meet, awareness about acquired immune deficiency syndrome (HIV/AIDS) treatment and tuberculosis and other diseases and rehabilitation of persons affected by HIV/AIDS, welfare of the physically and mentally challenged, welfare of the scheduled castes, scheduled tribes, backward classes, environmental programs, survey for socio-economic and other welfare programs, preservation and rehabilitation of victims of natural disasters, awareness against social evils, rehabilitation of victims of heinous crimes, rehabilitation of beggars, bootleggers, rehabilitation of victims of heinous crimes, rehabilitation of beggars, bootleggers, child labor etc, creating other assistance to institutions establishment or persons engaged in such relief work and any other activities related to above.

**E) CULTURAL OBJECTS:**

Celebration of National events (Independence/Republic Day/festivals, preservation/ Films etc. maintenance of places of historical and cultural important, Preservation of ancient/tribal art forms, preservation and promotion of cultural heritage and literature of India, cultural shows like drama, dances, music, folklore other related cultural performance arts and crafts and any other activities related to the above.

F) To grant aid or render assistance to other public charitable Trust Or any other institutions who are engaged in above similar activities.

**2. MEMBERSHIP OF THE TRUST:**

The membership of the trust shall be of the following classes:

**i) Managing Trustee:**

The Life Member of trust shall consist of Persons who pay a contribution of RS. 5,000/- towards the corpus of the trust and admitted as life members of the trust. Such members will be Life members of the trust unless removed from such Membership by the Board of Trustees for acting in a manner prejudicial to the interests of the trust.

**ii) Members Trustees:**

Ordinary Members shall be such individuals, firms or incorporated bodies who pay an annual subscription that will be pay RS. 500/- fixed by the trust. Such annual subscription or donation or contribution shall be payable in advance for each calendar year in full and falls due on the 1<sup>st</sup> January each year shall be payable before the end of March of the Year.

The Board of Trustees may vary from time to time decided by the number of Life and Ordinary members and also revise the amount of subscription.

**3. FUNCTIONS OF THE BOARD OF TRUST:**

The managing Trustee shall hold office for a period of their lifetime. The managing Trustee in consultation with the trust board may appoint and remove any Member in the larger interests of the Trust. Any vacancy arising in the office of the Member by reason on death, retirement and for other reasons shall be filled up by the Managing Trustee whenever they desire if necessary during their life time. The Managing trustee may delegate all or any of the powers vested in him as managing Trustee. In the event of the Managing Trustee relinquishing the Office by reason of death or for any other reason, his successor nominated by them shall discharge all the functions of the Managing Trustee including filling up the vacancies in the Trust or also removal of member if need be.

**4. THE MANAGING TRUSTEE SHALL HAVE THE FOLLOWING POWERS:**

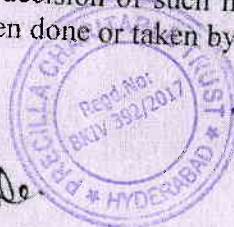
- (a) To have complete and effective control over the management of Affairs of the Trust.
- (b) To appoint a qualified Chartered Accountant for Auditing of the accounts of the Trust. Such appointment shall ordinarily be for a period of one year and renewable at their discretion;
- (c) To nominate or remove any member in consultation with the Board from the office;
- (d) While implementing and carrying out the objects and activities of the Trust, the decision of the Managing Trustees shall be final;
- (e) To institute, conduct, defend, compound, withdraw or compromise, adjust, refer to arbitration or abandon any legal, judicial or Quasi judicial proceedings, claims, disputes for and on behalf of the trust or members and employees concerning the affairs of the trust;
- (f) To sign and verify plaints, statements, affidavits, or other proceedings before all courts, Government authorities, Tribunals, Tax Authorities, Corporation or Municipal Authorities and also Quasi-Governmental authorities;
- (g) To maintain the minutes of the proceedings of the meetings and proper accounts for all the funds and assets and properties of the trust. The accounts of the trust shall closed on the 31<sup>st</sup> day of March every year;
- (h) **To maintain Bank Account SINGAL in any nationalized / scheduled banks in the name of the trust. Trustee shall have power to transactions like SINGAL, we accept Donation & raise Funds Loans.**
- (i) The Managing Trustee will be entitled to receive expenditure and services to all expenses actually incurred by him in connection with the trust or their duties relating thereto; and
- (j) To do such other acts deed consistent with the powers conferred herein and such other acts authorized by the Board of Members by a resolution.

**5. THE MEMBER TRUSTEE SHALL HAVE THE FOLLOWING POWERS:**

- (a) The Members Trustees shall assist the Managing Trustee in day to activities for the welfare of the trust.
- (b) The member Trustees may meet as often as may be necessary and record the minutes of proceedings in the Minutes Book incorporating the resolutions in regard to the manner in which the objects of the trust are to be carried out
- (c) particular purposes for which the trust and property and funds may be spent or utilized from time to time.
- (d) All or any of the trust's powers vested in the Board of Trustees may be exercised from time to time by a resolution passed by the majority of the trustees present at the meeting of the board of trustees and any action or decision of such majority of the Trustees shall be as valid and effective as if it has been done or taken by all Trustees.

**5. PROCEEDINGS OF THE TRUST:**

1. The Board of Trustees shall meet once a year or as often as necessary on the requisition of the majority of the Trustees or of the Managing Trustee. The quorum for the meeting shall be 2/3<sup>rd</sup> of the total;
2. The managing Trustee of the Trust shall normally preside over all the meetings of the Board of Trustees and in the absence of Managing Trustee, any member Trustee selected by the Board or Trust and will preside the meeting.
3. Normally, the vote of majority present at the meeting shall prevail, In case of equal votes the founder Trustee shall have the casting vote. But any resolution, if
4. in the opinion of the Managing Trustee is inconsistent with the aims and objects of the Trust or it's welfare, they can declare the same as null and void;
5. The Board of Trustees shall also be competent to pass any resolution by circulation among them and thus shall be ratified at the next meeting or the next adjourned meeting of the Board of Trustees;
6. The Trustees may apply the funds of the Trust for any of the above said objective either by the trust itself establishing, running or maintaining such institutions or by making donations or contributions to other trust of institutions for carrying out any of the above said objects.
7. The income of the Trust will be solely utilized towards the objects of the trust
8. The income of the trust will be for the benefits of all irrespective of age, caste, Religion, color, sex etc.
9. The name of the trust is irrevocable.
10. The charitable activities would be confined to the Territory of India.
11. The activities would be purely charitable / non-religious in nature not motivated for profit.
12. Any vacancy in the office of the Managing Trustee shall be filled up by the board by appointing there to one of the trustee or their successors;
13. The managing Trustee for the time being of the Trust, shall arrange for the maintenance correct and proper accounts of the receipts and disbursements and of
14. The liabilities incurred and of the assets acquired and for auditing every year of the accounts of the trust and of the income and expenditure relating thereto
15. The board shall have power to accept contribution in Money or Property either by way of addition to the trust funds generally or for any one or more of the specified objects of the trust in either case such contributions shall be dealt with either as capital or as income according to the directions of the donors the time of the gift;
16. The Board shall have power to call in and covert into cash the trust properties and realize them in such manner as is authorized herein;
17. The Board shall have full power of the management of trust properties and funds they shall have control over the finances of the trust. They shall likewise have full powers of construction and maintenance of Hospitals, Nursing Homes, Old age homes, Schools, Institutions and all the terms of the trust hereby created; self sufficient function, income generate programs.

18. Whenever, the administration of the trust hereby created or for the establishment, development and conduct of the several institutions maintained hereunder, grant in aid from Government are applied for and obtained and it becomes necessary for the due performance of the conditions of such grants for purchase of lands and for administration, conduct and maintenance of such institutions.

19. The board shall have power to apply for and obtained grant-in-aid from the governments and arrange the terms on which the securities to Government may be granted and executed;

20. The Managing trustee shall have power to custody of the Document of title to the properties of the trust and all other documents, accounts and other papers, relating to the trust and the same shall be open to inspection by any trustee on reasonable notice during office hours of the trust.

6. The investment of funds of the society shall be made in accordance with the provisions of the section 13[1] [c] of I.T. Act 1961.

7. **FUNDS:** The funds shall spent only for the attainment of the objects of the trust and no portion thereof shall be paid or be transferred directly or indirectly to any of the members through any means. Any surplus funds available with the trust shall be invested in such modes as may be specified Under Section 11(5) of Income Tax Act from time to time. **The funds of the trust shall constitute from the general public, institutions, grants from the Central & State Government.**

#### 8. AMENDMENTS:

No amendment or alteration shall be made in the purpose of the trust unless it voted by 2/3 of its members present at a special meeting convened for the purpose and confirmed by 2/3 of the members present at a second meeting and without the prior approval of Director of Income Tax(Exemptions)Hyderabad. The accounts of the society shall cease on 31<sup>st</sup> March, every year and the accounts shall be audited by a Chartered Accountant and shall be placed in the ensuring annual General Body Meeting.


